- Program Instruction (PI): <u>ACF-PI-HS-20-07</u> Summary: The OHS has traditionally used the CLASS tool as an assessment of HeadStart programs. However, due to the Federal emergency caused by the novel coronavirus disease 2019, OHS has not been able to send observers on-site to conduct CLASS reviews. This Interim Final Rule gives the Office of Head Start some flexibility to put programs into the Designation Renewal System without CLASS data. This interim final rule applies to Head Start programs that are applying for a new grant cycle. MAPS Head Start is in the second year of the five year grant cycle and therefore will not be affected by this change.
