The purpose of the closed session is to consider the negotiation strategies/options available to the Board as it considers the owner petitions for detachment related to property in the Town of Hamburg (and Maple Grove School) from Merrill Area Public School District to Athens School District and to confer with legal counsel who is rendering legal advice regarding the potential/likelihood of litigation associated with doing so, and take possible action related to the same; to discuss a support staff member's request for a temporary leave of absence; and, consideration of (and possible action regarding) applications for participation in the Early College Credit and Start College Now programs; discuss the approval of the employment contracts of administrators who have accepted the material changes to the contract; potential discussion of preliminary consideration of nonrenewal of employment contracts of administrators who have not accepted the material changes to the contract for the purpose of formally issuing the contracts with the material changes to the administrators; review a prior approval of vacation allowance related to an individual administrator contract; and, discuss revisions to the superintendent's contract for the upcoming contract cycle.
