## Merrill Area Public Schools Regular Board of Education Meeting October 27, 2021 – Minutes

The meeting was called to order by President Kevin Blake at 5:32 PM in the Merrill High School Auditorium.

MOTION by Smith, second by Volpe to approve the revised tax levy of \$9,960,417 for Fund 10, \$546,603 for Fund 38, and \$166,000 for Fund 80 for a grand total of \$10,673,020; revised

2021-22 fiscal year budget and the corresponding 6590 Budget Adoption Form for publication in the Foto News; and, revised Treasurer's report from FY21. Motion carried unanimously.

MOTION by Ashbeck, second by Osness to approve the Head Start Annual Report as presented to the Board. Motion carried unanimously.

There was a Head Start Training for the Board of Education.

MOTION by Ashbeck, second by Krueger to approve the purchase of the fencing project upon receipt of funds from the Booster Club. Motion carried unanimously.

MOTION by Krueger, second by Ashbeck to approve the purchase of a backup generator at the School Forest. Motion carried unanimously.

MOTION by Smith, second by Ashbeck to approve the select updates to both the Teacher and Support Staff Handbooks as presented for the 2021-2022 school year. MOTION by Smith to rescind his motion and move item f to a discussion following the consent agenda, second by Ashbeck. Motion carried unanimously.

MOTION by Osness, second by Krueger to approve the permanent creation of an additional full-time teacher at PRSYL beginning December 2021 as well as the configuration presented in options #3 or #4 depending on the directive from the Office of Head Start. Motion carried unanimously.

MOTION by Smith, second by Liberty to approve hiring five additional aide positions at Kate Goodrich Elementary School. Motion carried unanimously.

MOTION by Volpe, second by Osness to approve the donation of funds from the anonymous donor valued at \$6,019.00 for a baseball scoreboard at the Merrill High School. Motion carried unanimously.

MOTION by Osness, second by Krueger to remove this topic (Facility and Transportation Updates) as a standing agenda item for all meetings and return related topics to the Facilities Committee on an as-needed basis. Motion carried unanimously.

MOTION by Volpe, second by Yingling to eliminate the use of district resources to contact trace individuals potentially exposed to positive Covid cases in the MAPS district. MOTION by Volpe, second by Yingling to rescind her motion. MOTION by Volpe, second by Yingling to have administrative reach out to Lincoln County Health Department to set up a meeting to discuss the Covid situation, protocols and responsibilities of each entity in an open session Special Board Meeting. Motion carried unanimously.

The Board discussed the Superintendent review process.

(b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations; (g) conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved; and,118.125 for the purpose of considering student Early College Credit and Start Now applications that may involve discussions of confidential student records, and to discuss other matters involving student records and personal histories that, if discussed in public, would likely have a substantial adverse effect on the reputations of the persons discussed. The purpose of the closed session is to discuss and consider (and possible action regarding) a remote work arrangement for an employee; for the consideration of (and possible action regarding) applications for participation in the Early College Credit and Start College Now programs; and, to conduct specified public business which for competitive or bargaining reasons requires a closed session, to wit, the consideration and discussion of the sale of personal and real property associated with Maple Grove School, and the division of assets and liabilities between Merrill Area Common Public School District and Athens School District, which may occur as a result of granting petitions for detachment of property in the Town of Hamburg, and to take action regarding the same. The Board may reconvene to open session and may take action upon the matters discussed during the closed session portion of the meeting. MOTION by Yingling, second by Ashbeck to adjourn into executive session. Motion carried on a roll call vote.

Volpe left the meeting at 8:49 p.m.
