II. Approval of the March 9, 2022, CTP Committee Meeting Minutes

#### III. Curriculum

MiddleSchoolMath Resource

Motions to approve the purchase of MiddleSchoolMath Resource for PRMS in the amount of \$131,190.00 for 2023-2028 school years.

See topic summary sheet above. Ms. Oginski elaborated on the three piloted resources. Teacher and student surveys provided feedback. The review tool was also utilized with each pilot. The chosen curriculum has a real world application

and will be for grades 5-8. Onsight training will also be provided by the company as well as training prior to the start of the school year. This is also for a six year purchase.

Motion by Woller, seconded Liberty to approve the purchase of MiddleSchoolMath Resource for PRMS in the amount of \$131,190.00 for 2023-2028 school years to be paid through the fiscal year 2021-2022 budget. Motion carried.

Mr. Murray addressed this topic. Middle school expenses are run through Fund 80 as a community fund and anyone can compete from eighth grade down. At the high school level, we have to follow the WIAA. Homeschool students can participate and charter school students cannot compete. At this time, unless we co-op, a charter school cannot participate.

1. Get Kids Ahead (GKA) Initiative (mental health funding opportunity)

See topic summary above. Ms. Baker reported that this is not a grant awarded opportunity. A district only had to accept to receive the funding opportunity. The funding amount is based on the district's pupil count. Further information will be forthcoming as more information/guidance is provided through DPI.

#### V. Technology

1. Update on Smartboards, iPad Refresh

Ms. Oginski shared that the district is at the age of refresh for Smartboards and Promethean boards. The district has been piloting BenQ Panels. Teachers have received training and have used the technology for part of a day. The panels will be moved between schools to pilot. Laptop refresh information has gone to HR/Finance and they won't be here in a timely manner. The district may look to add Chromebooks to classrooms and keep iPads or go 3-12 Chromebooks and K-2 iPads. We are getting feedback on Chromebooks and then collaborative decision making will occur. Feedback has been positive, thus far, for the BenQ Panels. The panel purchase may be able to come to CTP in May and Chromebook, etc. will come for approval during the summer of 2024 and this roll-out will be for the entire district.
